APPLICATION REQUIREMENTS FOR FOREIGN STUDENTS

An international candidate who is currently enrolled as a senior in a high school or who has already earned a high school diploma equivalent to a Turkish High School Diploma will be taken into consideration provided that he/she

- a) holds a foreign nationality,
- b) is a native-born Turkish citizen but has ceased to be a citizen by the courtesy of the Ministry of Interior and within the minors registered on the document indicate the cease to be citizen of Turkey, the ones who can certify that he/she holds the official document regarding the use of rights granted by Turkish Citizenship Law,
- c) has taken Turkish citizenship while holding a foreign nationality / dual citizens within this context,
- d) is a Turkish citizen who has completed his/her entire high school education in a foreign country other than Turkish Republic of Northern Cyprus (TRNC) (including the ones who have completed their high school education in a Turkish high school in a foreign country other than TRNC),
- e) is a TRNC citizen residing in TRNC, has completed his/her high school education in TRNC and taken the GCE AL exam

Applications of the following candidates will not be taken into consideration

- a) Turkish citizens (excluding the ones who have completed the last three years of their high school education in a foreign country other than TRNC),
- b) TRNC citizens (excluding the ones who have completed their high school education in TRNC and taken the GCE AL exam after they have been educated in a college in TRNC),
- c) Dual nationality applicants whose first nationality is Turkish (excluding the ones who have completed the last three years of their high school in a foreign country other than TRNC),
- d) Applicants who hold dual nationality one of which is TRNC (excluding the ones who have completed their high school education in TRNC and taken the GCE AL exam),
- e) Turkish citizens who have completed their high school education in Turkey or TRNC.

Required Documents for Application

- b) Photocopy of the High School Diploma (For the candidates who are enrolled as a senior but has not received their diploma: Temporary Graduation Document; for the candidates who has not graduated yet: An official document that indicates the

candidate will be graduating before the academic year they applied for). **The documents are required with their Turkish translation if they are not originally Turkish.**

- c) Approved transcript indicating the grades of the courses taken during high school education. Turkish translation will be added if the transcript is not Turkish.
- d) Exam result if available (The exams that are indicated in the application form)
- e) Photocopy of the passport if available (the page with the ID information)
- f) Two 4.5 x 6 cm color photos which face is facing the camera, reflecting the current appearance, taken within the last 6 months.

Necessary Amount of Financial Assurance for the students to continue their educations

Foreign students are obliged to submit their bank receipts in the amount of \$ 2000 cash or a statement of assurance for the same amount.
